

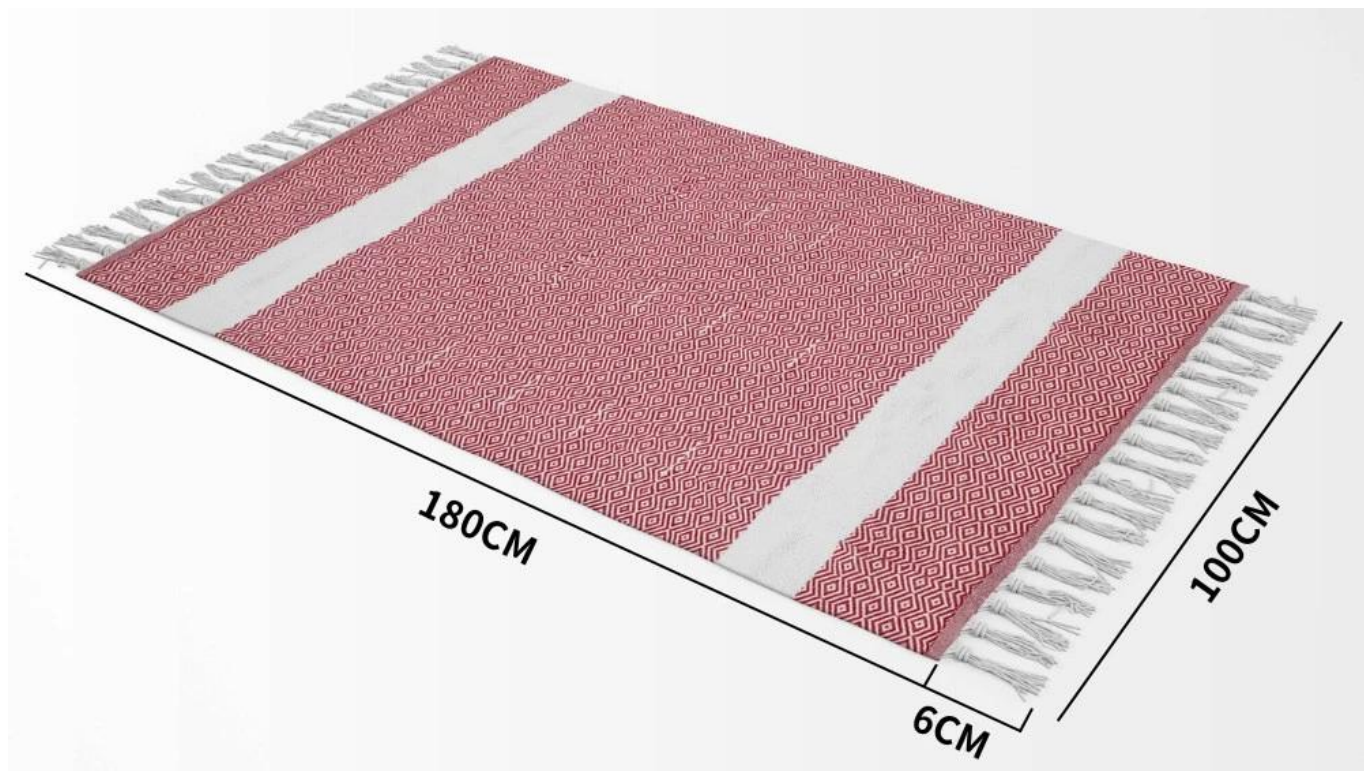

Colorant extraction refers to the colorant extraction and subsequent reduction according to EN ISO 14362-1:2017 clause 10.1 and relevant clauses.
4-Aminodiphenyl (CAS No. 92-67-1), 2-Naphthylamine (CAS No. 91-59-8) and 2,4-Diaminoanisole (CAS No. 615-05-4) can be indirectly generated from some colorants which do not contain these amines azo bound. The use of banned azo colorants cannot be reliably ascertained without additional information. In case PU is used, e.g. PU Foams or coatings, it cannot be ruled out that MDA (CAS No. 101-77-9) and TDA (CAS No. 95-80-7) can be released from PU material, not from banned azo colorant. Similarly, for pigment prints, MDA will be released from a chemical fixing agent.
